about Beneficiaries & Policy Owners

Allianz Life Plan policies do not allow for nominated beneficiaries; however, you may be able to add an additional owner to your policy. There is a maximum of 2 Policy Owners per policy.

Policies with 1 Insured:

If you are the only person insured on your policy, you have the option of adding an additional Policy Owner to your Life Insurance policy. As a joint Policy Owner, this person has the same rights over the policy as you, including cancellation. In the event of a Life Cover claim, the surviving policy owner would receive any benefit paid. For more information on how benefits are paid, please refer to your Product Disclosure Statement (PDS).

Should you wish to add an additional Policy Owner to your policy, please complete and return the Addition of Policy Owner form over the page.

Policies with 2 Insureds:

If there are 2 people insured on your policy, each person is automatically a joint Policy Owner, and no additional Policy Owners can be added. For information on how benefits are paid, please refer to your Product Disclosure Statement (PDS).

Important Information:

The request of one Policy Owner will bind all Policy Owners.

A Policy Owner will have all rights over the policy and may request changes on behalf of any other Policy Owner.

Requested changes may include, but not limited to:

- Decrease of cover(s)
- Removal of cover(s), Policy Owner or a Life Insured
- Cancellation of the policy
- Update contact details

Policies cancelled at the request of a Policy Owner cannot be reinstated without full reapplication.
